Description

Luban HP2148TC is manufactured using the Spheripol Technology. Luban HP2148TC is a nucleated homopolymer polypropylene used in injection molding. Luban HP2148TC is recommended for houseware, Thin Wall Injection Molding (TWIM) food and non-food containers.

Processing Guidlines

The Typical Processing Conditions for Luban HP2148TC are:

Melt temperature $220 - 260 \,^{\circ}\text{C}$

Holding pressure 200 – 500 bar maximum to avoid sink marks

Mold temperature 20 - 40 °C Injection speed High

Shrinkage 1-2% depending on wall thickness and molding parameters

Note: Processing parameters should only be used as guidelines. The above properties values are not to be construed as specifications.

Storage and Handling

Luban HP2148TC must be protected from direct sunlight and should be stored in a shaded and completely dry area. During handling and processing, the material should be kept in a well-ventilated area to prevent the accumulation of dust and fumes. Contact with strong oxidizers, excessive heat, sparks or open flame should be avoided as this could initiate the degradation process and consequently impact the quality of the material.
